

Determination of admission of guilt fines: In terms of Section 27 of the Disaster Management Act 57 of 2002, read with the Regulations issued in terms of section 27(2) of the Disaster Management Act,2002(Act No. 57 of 2002) and published in Government Notice No. 43258, NO.R. 480 on 29 April 2020

I, Sibongile Raphahlelo, Chief Magistrate, Eastern Cape Region 1, and Judicial Head and Magistrate for the district of PORT ELIZABETH determine, in terms of section 57(5)(a) of The Criminal Procedure Act, Act 51 of 1977, the amounts set down below, as Admissions of guilt for the district of Port Elizabeth and the Area known as Eastern Cape Region 1, and the district of Port Elizabeth for the offences, as annexed hereto.* (This determination repeals all previous determinations).
