DETERMINATION OF ADMISSION OF GUILT FINES: OFFENCES IN TERMS OF THE DISASTER MANAGEMENT ACT REGULATIONS, 2020: DISTRICT OF TSHWANE NORTH

I have been made aware that admission of guilt fines have been determined in certain districts in respect of contraventions of the provisions of the Regulations that were promulgated in terms of section 27(2) of the Disaster Management Act, No. 57 of 2002 (Regulations).

In consultation with members of the Judiciary, more specific also the Magistrate for the District of Tshwane North, the National Prosecuting Authority, and other stake holders, I have determined that:

A. Admission of guilt fines as per the attached Determination, in respect of the District of Tshwane North, should be made for only two offences, namely, contraventions of Regulation 11B (1)(a)(i) and Regulation 11B (1)(a)(ii) read with Regulation 11 G of Government Gazette 43148.

B. The offences under the Regulations, save for two offences, are of such a serious nature that the determination of admission of guilt fines would not be in accordance with justice or in the interests of justice within the District of Tshwane North.

Therefore, the determination of admission of guilt for the District of Tshwane North (Pretoria North and Soshanguve Court) is made as per the addendum attached hereto.
