

**AD HOC DETERMINATION OF ADMISSION OF GUILT FINES IN  
TERMS OF SECTION 57(5)(a) OF THE CRIMINAL PROCEDURE  
ACT, 1977 (ACT 51 OF 1977)**

**DISASTER MANAGEMENT ACT, NO 57 OF 2002,**

The following admission of guilt fines are determined in terms of section 57(5) of the Criminal Procedure Act, 1977 (Act No. 51 of 1977) for the Magisterial District of **PIETERMARITZBURG** and **effective from 29 December 2020**.

These admissions of guilt fines are issued under section 27(2) of the Disaster Management Act, No. 57 of 2002 and Regulations published by Government Gazette Notice No.R.1423 dated 29 December 2020.

**These fines are valid for the duration of Adjusted Alert Level 3.**

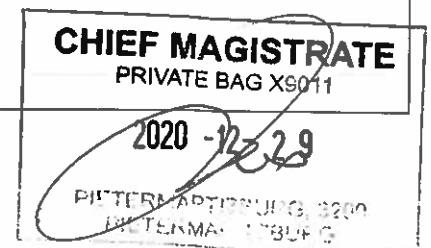


