

ADDENDUM TO THE DIRECTIVES ISSUED BY THE JUDICIAL HEAD OF ADMINISTRATIVE REGION 6, KWAZULU-NATAL AS DELEGATED BY THE CHIEF JUSTICE IN TERMS OF SECTION 8(3) OF THE SUPERIOR COURTS ACT, 2013


According to paragraph 8 of the Directives the following was said:

8. In view of the postponement of trials, it is envisaged to scale down on the number of courts that will be operational during this period and such information will be communicated to the Judge President, Director of Public Prosecutions, Provincial Executive KwaZulu-Natal and the Regional Head, KwaZulu-Natal;

The lists of courts that will be in operation from 27 March 2020 to 16 April 2020 in respect of each Area Cluster within Administrative Region 6, KwaZulu-Natal, are attached hereto for ease of reference.

We will be viewing and monitoring the situations in all courts on daily bases and where amendments will be necessary, they will be effected accordingly.
