2. HOW TO CREATE A CASE?

Please follow the instructions as per Directive dated 18 September 2020: -

Amended Gauteng Consolidated Directive re Court Operations during the National State of Disaster_18 09 2020

- 1. Open Internet Browser and enter URL https://sajustice.caselines.com and log on.
- 2. Click on View Case List
- 3. Click on Would you like to Create a case ?
- 4. If you do not have the **Create a Case** button available, contact Helpdesk for assistance.
- 5. ALL Cases Created should be linked to a Template. Failure to Use a Template will result in a defective application as per the Practice Directive referred to above.



IMPORTANT NOTE – (Very Important Steps)

1. Only use the fields marked A, B, C, D, E on the screen shot



- Navigate to Use Template and on drop down select correct template and verify the correct Template
- For Cases initiated with the Pretoria High Court select
 "Court User Group Case Creation Template Pretoria High Court"
- c. For Cases initiated with the Johannesburg High Court select "Court User Group Case Creation Template – Johannesburg High Court"
- d. On the left-hand side of the Front Cover Page, click on populate the Front Cover Page.
- e. Navigate to **Name*** field and enter case name, do not use quotation marks on the name field
- f. Type the Name of the Case in the **Name*** field, being that of the parties to the case recorded in full
- g. Enter a **prefix** for the case type before the case name, e.g. **Rule 43**: DLAMINI, Gideon vs DLAMINI, Sarah.
- h. For Tax Court matters the case name, e.g. **Tax Court Appeal**: ABC Pty Ltd vs CSARS or **Tax Court Application**: DLAMINI, Sarah vs CSARS.
- i. When the case or application type changes, the prefix must be amended accordingly.



- j. Where applicable, the classification in terms of Practice Directive 2 of 2019 should precede the prefix.
- k. Type the reference being the case number, recorded with the year in full and without any 0 preceding the case number, e.g. 2005/44; 2012/123; 2019/93222

3. HOW TO VIEW PROGRESS ON YOUR CASE?

- 1. Go to https://sajustice.caselines.com & login
- 2. Click on View Case List
- 3. Find your case in the case list
- 4. Click on Update Case
- 5. On Case Home Check if the Registrar has made any annotations to the Case on the Front Cover Page or the additional Note fields below the Front Cover Page
- 6. Check if the Hearing Date has been applied by the Registrar on the Case (Do Not Modify or Add a Hearing Date This is the Function of the Registrar and other Court Officials)
- 7. Click on Review Evidence
- 8. Check for **Notes** made on the Case by the Registrar or other Court Officials

Note – Registrars and other Court Officials will use CaseLines to communicate with Parties. Please check back on your Case for any progress updates.
