**TO: HEAD OF SECURITY AND ALL SECURITY PERSONNEL, COURT MANAGERS, CHIEF REGISTRARS, CHIEF LIBRARIANS, AND JUDGES OF THE GAUTENG DIVISION OF THE HIGH COURT**

1. It has been brought to my attention that Mr Senzo Wiseman Mkhize continues to come into the Court Buildings and demanding a right of appearance before a number of Judges, allegedly on the instruction of "clients." Mr Mkhize was struck off the roll of practicing legal practitioners and all his attempts at appealing that order have failed (see attached orders from the Constitutional Court marked "A" and "B").
2. Based on the above, I, as Head of Court, direct that Mr Mkhize forthwith not be allowed access to the Court Buildings as he has no legitimate business therein.


**ORDER**

CORAM: Zondo CJ, Maya DCJ, Kollapen J, Madlanga J, Majiedt J, Mathopo J, Mhlantla J, Rogers J and Tshiqi J.

The Constitutional Court has considered the application for leave to appeal directly to it to confirm the order of the High Court and the application for direct access for an interdict. It has concluded that no case has been made out for a direct appeal as the order sought to be confirmed is not an order of constitutional invalidity envisaged in section 167(5) of the Constitution and thus does not require confirmation by this Court. The Court has also concluded that no case has been made out for direct access. Consequently, leave to appeal and direct access is refused. The Court has decided not to award costs.

Order:

1. Leave to appeal directly is refused.
2. Direct access is refused.

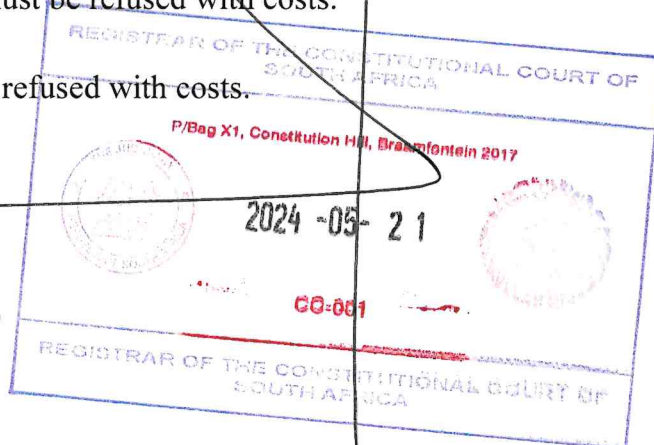
