1. All matters to be heard via electronic media. A link will be provided, which same link will be used throughout the week.
2. Court and hearing will start at 10:30.
3. Removals, settlements and postponements will be called first. Thereafter the applications will be called in order of seniority.
4. All court documents to be uploaded by no later than 16h00, two days prior to the hearing date. Failure to comply may cause the matter to be removed from the roll.

5. Heads of argument to be uploaded no later than 16h00, two days prior to the hearing date. Failure to comply may cause the matter to be removed from the roll.
- 6. Draft court orders must be uploaded prior to commencement of the hearing.**
7. Complete details of the parties' representatives (including Counsel), Judge's name, date of hearing, manner in which the matter is heard and Court number (if applicable) must be included in the draft order.
8. Details of the Road Accident Fund must also be included in the draft order, i.e. claims handler and claim/link number (if available).

Removals or postponements which occur the day before the matter is to be heard must also be uploaded onto Caselines.
