1. Kindly find hereunder the Family Court roll for the week of 26 January 2026.
2. The Family Court roll is divided as follows:
 - Odd numbered matters (i.e. 1, 3, 5 etc.) will be heard before Judge Tolmay.
 - Even numbered matters (i.e. 2, 4, 6 etc.) will be heard before Acting Judge Van Niekerk (Please contact Ms Tshepang Mpuru TsMpuru@judiciary.org.za in relation to Acting Judge Van Niekerk's roll).
3. The allocation before **Judge Tolmay** is the following:
 - **Monday, 26 January 2026 at 10h00 – all odd numbered unopposed divorces and all Rule 43 matters (opposed and unopposed) will be heard.**
 - **Tuesday, 27 January 2026 at 10h00 – all odd numbered other family court matters, all opposed divorces and urgent family court matters will be heard**
4. **NO further documents may be uploaded on Caselines!**
5. Parties must ensure that all relevant papers are filed (i.e. notice of set down, practice notes and draft order). Requests to upload further papers must be sent to [NNair@judiciary.org.za](mailto>NNair@judiciary.org.za). A practice note setting out the nature of the case, a

summary of the facts and arguments must be filed before close of business on 22 January 2026.

6. The master bundle must be properly indexed and paginated, annexures must be clearly marked and separated. Failure to adhere to this will result in your matter being removed from the roll.
7. Matters that do not appear on CaseLines by close of business (16h00pm) on 22 January 2026 will not be dealt with. If practitioners experience any problem in this regard the Judge's Secretary must be informed by email by 21 January 2026.
8. In divorce matters where there are minor children - viva voce evidence is required.
9. In divorce matters where there are no minor children, and no evidence affidavit was uploaded by 16h00 on 22 January 2026 – viva voce evidence is required.
10. Witnesses are urged to dress appropriately should they appear in court.
11. All matters will be heard in open court - please see the day-roll for the court that will be used for the hearing).
12. All introductions will be done in chambers in office 148 at the Palace of Justice at 09h30am. Please be punctual.
13. Please indicate any postponements, settlements or removals timeously. Same may be communicated through email to [NNair@judiciary.org.za](mailto>NNair@judiciary.org.za).
14. Parties are reminded to ensure that the case number, roll number and parties names on the draft orders are correct as well as all annexures.
15. Only 1 draft order is required to be handed up.

16. The general Family Court Directives are to be STRICTLY complied with.
17. With regard to urgent family court matters – please note that there will be strict compliance with the rules pertaining to urgency especially in light of the short turnaround time in the Family Court.
