## Media Invitation

### CHIEF JUSTICE MOGOENG MOGOENG TO ADDRESS STAKEHOLDERS ON THE OCCASION OF THE PRESENTATION OF THE JUDICIARY ANNUAL REPORT, 23 NOVEMBER 2018

The Constitution of the Republic of South Africa, 1996 provides that the Judiciary is independent and subject only to the Constitution and the law. The Chief Justice is the Head of the Judiciary and exercises responsibility over the establishment and monitoring of the Norms and Standards for the exercise of judicial functions of all Courts.

The Heads of Court, led by the Chief Justice, have taken the resolution to present an annual report on Judicial Functions and Court Performance for the South African Judiciary for the year ending 31 March 2018. This will be a historical event as it is the first time the Judiciary, as an Arm of State, will take the lead on accounting for its work, and for the power and authority the State has endowed to it. Legal Day will henceforth be an annual event during which the Chief Justice will, on the behalf of the Judiciary, present the Judiciary Annual Performance Report; and deliver an address on the state of the Judiciary.

The Chief Justice has invited various justice sector stakeholders to be part of this inaugural event.
