## PROCEDURE TO APPLY FOR JCMM DATE WHEN IN POSSESSION OF UNSIGNED PRE-TRIAL MINUTE

It is the practice in this Division that a pre-trial is held just before approaching the Registrar for a Judicial Case Management Meeting hearing with a signed pre-trial minute.

Many of the attorneys acting for the Road Accident Fund just do not respond to a request for a pre-trial meeting or have no mandate to do so.

This of course prejudices the plaintiff's attorneys.

In turn, some of the plaintiff's attorneys put in little effort to contact the Road Accident Fund's attorneys and rather approach this Office to hold pre-trials before a Judge.

The result of the above is that this Office is inundated with requests for pre-trials before Judges, which cannot be accommodated. An attorney for a plaintiff can approach the Registrar of Judicial Case Management Meetings with an unsigned pre-trial minute accompanied by an affidavit setting out the details of:

- (a) at least two attempts to hold a pre-trial conference with the defendant's attorneys; or
- (b) at least one attempt, if the attorney has withdrawn or has no mandate, in holding a pre-trial with the Road Accident Fund handler of the matter.
