**ZUMA MATTER, 8 DECEMBER 2020, PIETERMARITZBURG HIGH COURT** 

Members of the media are advised that the matter involving the Thales Group and former

President Jacob Zuma will return to the Pietermaritzburg High Court on 8 December 2020.

To limit the spread of COVID-19, strict social distancing protocols will be observed in the media

and public gallery. To ensure the safety of all court users, members of the media and the

public are requested to follow all security procedures as will be communicated by court

officials.

Please be advised that a very limited number of seats are allocated for accredited members
