APPLICATION FOR LEAVE TO APPEAL: STATE V ZUMA AND ANOTHER (THALES SOUTH AFRICA) , 31 JANUARY 2022, PIETERMARITZBURG HIGH COURT

Members of the media are advised that the application for leave to appeal in the State v Jacob Zuma and Another (Case number: CCD30/2018) will be heard by the KwaZulu Natal Division of the High Court, Pietermaritzburg, on 31 January 2022.

In an attempt to prevent the spread of COVID-19, strict social distancing protocols will be observed in the courtroom. Members of the media and the public are requested to follow all security procedures as will be communicated by court officials in order to ensure the safety of all court users.

Media access to the venue will be by accreditation only. Members of the media interested in covering the proceedings are requested to apply for accreditation by submitting their details using the template provided to Ms Lusanda Ntuli at L.Ntuli@judiciary.org.za, and CC ZMakgoale@judiciary.org.za and lusanda02@gmail.com, by no later than **14h00 on Wednesday, 26 January 2022**. **Accreditation applications not submitted using the provided template will not be considered.** Personal information will be processed in line with the Protection of Personal Information Act (Act No. 4 of 2013).

Accreditation cards will be available and distributed to approved applicants. This will be communicated via email once accreditation has been finalised.
