### **APPLICATION FOR LEAVE TO APPEAL: STATE V ZUMA AND ANOTHER (THALES SOUTH AFRICA) , 16 FEBRUARY 2022, PIETERMARITZBURG HIGH COURT**

Members of the media are advised that judgment will be delivered in the State v Jacob Zuma and Another (Case number: CCD30/2018) in open court at the KwaZulu Natal Division of the High Court, Pietermaritzburg, on 16 February 2022.

In an attempt to prevent the spread of COVID-19, strict social distancing protocols will be observed in the courtroom. Members of the media and the public are requested to follow all security procedures as will be communicated by court officials in order to ensure the safety of all court users.

Media access to the venue will be by accreditation only. Accreditation cards will be distributed to approved applicants. This will be communicated via email once accreditation has been finalised.
