JSC INTERVIEW FOR DEPUTY CHIEF JUSTICE, JUNE 2022

On 7 April 2022 the Chief Justice received a letter from the President of the Republic of South

Africa in which the President indicated that he is considering appointing Justice M M L Maya,

President of the Supreme Court of Appeal, as Deputy Chief Justice of the Republic of South

Africa. Justice Maya has subsequently accepted this nomination.

The President of the Republic further indicated in his letter that he seeks to consult the Judicial

Service Commission (JSC) on her suitability for such appointment. The JSC will therefore

interview Justice Maya for the vacant position of Deputy Chief Justice of the Republic of South

Africa on 20 June 2022.
