PIETERMARITZBURG HIGH COURT

The matter State v Jacob Zuma and Another (Case number: CCD30/2018) is set down for

start of trial, in open court, at the KwaZulu Natal Division of the High Court, Pietermaritzburg,

on 11 April 2022.

Strict social distancing protocols continue to be observed in the courtroom. Members of the

media and the public are requested to follow all security procedures as will be communicated

by court officials in order to ensure the safety of all court users.

Media access to the venue will be by accreditation only. Members of the media interested in

not be considered. Personal information will be processed in line with the Protection of

email once accreditation has been finalised.
