### **CHIEF JUSTICE RAYMOND ZONDO TO PRESENT THE ANNUAL JUDICIARY REPORT, 24 FEBRUARY 2023**

The Chief Justice of the Republic of South Africa, Judge Raymond Zondo, has, in consultation with the Heads of Court, determined that the presentation to the public of the Annual Judiciary Report for the 2021/22 Financial Year will take place on Friday, 24 February 2023 at 10h00.

The Constitution of the Republic of South Africa, 1996, provides that the Judiciary is independent and subject only to the Constitution and the law. The Chief Justice is the Head of the Judiciary and exercises responsibility over the establishment and monitoring of the Norms and Standards for the exercise of judicial functions of all Courts. The South African Judiciary holds the Judiciary Day to present its Annual Performance Report on Judicial Functions and Court Performance.

On 24 February 2023, the Chief Justice will, on the behalf of the Judiciary, present the Judiciary Annual Performance Report and deliver an address on the state of the Judiciary.

The event will be held at the Constitutional Court in Braamfontein, and streamed live on the Judiciary YouTube channel - <https://www.youtube.com/c/JudiciaryRSA>.
