RESERVED JUDGMENTS REPORT

1. Introduction

- 1.1. The Judicial norms and standards for the performance on judicial functions provide, in terms of paragraph 5.2.6, that judgments in both civil and criminal matters, should generally not be reserved without a fixed date for handing down. Judicial Officers have a choice to reserve judgments *sine die* where circumstances are such that the delivery of a judgment on a fixed date is not possible. The norms and standards further determine that save in exceptional cases where it is not possible to do so, every effort shall be made to hand down judgments no later than three (3) months after the last hearing.
- 1.2. Article 10(2) of the Code of Judicial Conduct adopted in terms of section 12 of the JSC Act, 1994 provides:

"A judge must deliver all reserved judgments before the end of the term in which the hearing of a matter was completed, but may:

- (a) in respect of a matter that was heard within two weeks of the end of that term; or
- (b) where a reserved judgment is of a complex nature or for any other cogent and sound reason and with the consent of the head of the court, deliver that reserved judgment during the course of the next term."
- 1.3. At the meeting held on 28 September 2018, the Heads of Court resolved that a reserved judgments report containing a list of judgments outstanding for more than 6 months, will be published on the Judiciary's website.

2. Reserved Judgments overview during the reporting period

- 2.1. The 2023 Court Term 3 sittings of the Constitutional Court, the Supreme Court of Appeal and the Labour Appeal Court commenced on 15 August 2023 and ended on 30 September 2023, whereas the Court Term 3 sittings of the High Court, commenced on 17 July 2023 and ended on 17 September 2023. The table 1 below provides an overview on the status of reserved judgments as at the beginning of Term 3 of 2023.
- 2.2. As at the beginning of Court Term 3 of 2023, a total of 1,255 judgments were reported as reserved. A total of 213 of these judgments, representing an overall 17,0% of the reserved matters, had been reserved and were outstanding for a period exceeding 6 months. The remaining 1,042 of these judgments, representing an overall 83%, had been reserved for a period of less than 6 months.

- 2.3. From the table below, it can be seen that nationally, out of a total of 1,255 judgments that were indicated as reserved, the Labour Court, Johannesburg with a total of 138 reserved matters, had the highest number of reserved judgments, followed by the Gauteng Division of the High Court, Pretoria with 137 reserved matters and Gauteng Local Division of the High Court, Johannesburg with 124 matters.
- 2.4. It is also noted that in terms of the total number of reserved judgments compared with the number of reserved judgments outstanding for more than 6 months in each of the Courts, the Northern Cape Division of the High Court, Kimberly had the highest proportion of reserved judgments (outstanding for more than 6 months), that is 21 out of 49, representing 43% of all matters in the Division, followed by the Labour Court, Durban with 39% (9 out of 23) and Labour Court, Gqeberha with 39% (18 of 46).
- 2.5. Comparing the statistics of the Superior Courts, it will be noted that the highest percentage of reserved judgments outstanding for more than 6 months were in the Gauteng Division of the High Court, Pretoria with a percentage of 16,0% (34 of 213 matters), followed by the KwaZulu-Natal Division of the High Court, Pietermaritzburg, with 12,1% (26 of 213 matters); and the Northern Cape Division of the High Court, Kimberley, with 9,9% (21 of 213 matters).
- 2.6. A noteworthy observation from the table below is that there were no reserved judgments, exceeding 6 months in the Eastern Cape Local Division of the High Court, Mthatha, Free State Division of the High Court, Bloemfontein, Limpopo Division of the High Court, Polokwane, Mpumalanga Local Division of the High Court, Middelburg, the Land Claims Court and Competition Court of Appeal.
- 2.7. It is also worth noting that the Electoral Court did not have any reserved judgments.
- 2.8. Table 1 provides a Superior Courts' status overview on the reserved judgments as at the beginning of the Court Term 3 of 2023.
