RESERVED JUDGMENT REPORT

1. Introduction

- 1.1 The Judicial norms and standards for the performance on judicial functions provide, in terms of paragraph 5.2.6, that judgments in both civil and criminal matters, should generally not be reserved without a fixed date for handing down. Judicial Officers have a choice to reserve judgments *sine die* where circumstances are such that the delivery of a judgment on a fixed date is not possible. The norms and standards further determine that save in exceptional cases where it is not possible to do so, every effort shall be made to hand down judgments no later than three (3) months after the last hearing.
- 1.2 Article 10(2) of the Code of Judicial Conduct adopted in terms of section 12 of the JSC Act, 1994 provides:
- “A judge must deliver all reserved judgments before the end of the term in which the hearing of a matter was completed, but may:
- (a) in respect of a matter that was heard within two weeks of the end of that term; or
 - (b) where a reserved judgment is of a complex nature or for any other cogent and sound reason and with the consent of the head of the court, deliver that reserved judgment during the course of the next term.”
- 1.3 At the meeting held on 28 September 2018, the Heads of Court resolved that a reserved judgments report containing a list of judgments outstanding for more than 6 months, will be published on the Judiciary’s website.

2. Reserved Judgments overview during the reporting period

- 2.1 The 2025, Term 2 sittings of the Constitutional Court, the Supreme Court of Appeal and the Labour Appeals Court commenced on 01 May 2025, whereas the sittings for the High Court, Labour Courts and Land Claims Court commenced from 14 April 2025. Table 1 below provides an overview of the status of reserved judgments as at the beginning of Term 1 of 2025.
- 2.2 As at the beginning of Term 2 of 2025, a total of **1,568** judgments were reported as reserved. A total of **279** of these judgments, representing an overall **18%** of the reserved matters, had been reserved and were outstanding for a period exceeding six (6) months. The remaining **1,289** of these judgments, representing an overall **82%**, had been reserved

for a period of less than six months. There is an increase of **one (1)** percentage points of matters reserved for a period exceeding six (6) months compared with that recorded in Term 1 of 2025.

- 2.3 From table 1 below, it can be seen that nationally, out of a total of **1,568** judgments that were indicated as reserved, the Gauteng Division of the High Court, Pretoria with a total of **369** reserved matters, had the highest number of reserved judgments, followed by the Labour Court, Johannesburg with **172** and the Western Cape Division of the High Court, Cape Town with **133**.
- 2.4 It is also noted that in terms of the total number of reserved judgments compared to the number of reserved judgments outstanding for more than six (6) months, the Labour Court, Cape Town had the highest proportion of judgments reserved for more than six months, that is **18** out of **38**, representing **47%** of all matters at the Court; followed by the Labour Court Durban with **33%** (**26** out of **78**), and the Labour Court Johannesburg with **31%** (**53** out of **172**).
- 2.5 Comparing the statistics of the Superior Courts, it will be noted that the highest percentage of reserved judgments, outstanding for more than six months, were in Labour Court, Johannesburg with **19%** (**53** out of **279** matters), followed by the Gauteng Division of the High Court, Pretoria with a percentage of **15%** (**42** out of **279** matters).
- 2.6 A noteworthy observation from the table below is that there were no judgments reserved for more than six (6) months, Eastern Cape Local Division of the High Court, Bhisho, Eastern Cape Local Division of the High Court, Gqeberha, Mpumalanga Local Division of the High Court, Middelburg, Competition Appeal Court, Labour Appeal Court.
- 2.7 It is also worth noting that the Electoral Court did not have any reserved judgments.
- 2.8 Table 1 below provides a Superior Courts' status overview on the Reserved Judgments outstanding as at the beginning of Court Term 2 of 2025.
