1. <u>In all matters</u> (opposed and unopposed) <u>a Practice Note as well as Heads of Argument</u> must also be served and filed (on Caselines only and <u>not</u> to be sent to the Judges' secretary) by all parties concerned. The application will then be adjudicated by means of an oral hearing, <u>unless there is a written indication that it will not be necessary.</u> Oral hearings will be conducted <u>via Microsoft Teams</u>, subject to a time limitation, if necessary.

Filing of papers which were <u>impossible</u> to upload on Caselines, must be done via email to the Judges' clerks, <u>with an affidavit</u> explaining what steps were taken to upload, when and by whom the steps were taken and why it was not possible to upload on Caselines.
