**The following processes and procedures shall apply to ALL the opposed motion matters before Vally J:**

1. Documents must be uploaded in all matters to *CaseLines*. Only matters that have been uploaded on *CaseLines* shall be heard. All non-compliant opposed motions shall automatically be removed from the roll.
2. A practice note must be e-mailed to the Judge's secretary if same has not been uploaded yet, as the Caselines bundles have already been frozen.
3. In the opposed motions in which the party appears in person, such an unrepresented party shall go to the Court building and approach the designated official at the Court building who shall render assistance to that litigant through the use of the virtual Courtroom. A notice to this effect shall be posted in the foyer of the Court by the Judge's Secretary.
4. The hearing of all opposed motions will be conducted as a videoconference on *Microsoft Teams*. All appearing Legal Practitioners are required to join the meeting on the day of the hearing at **09:45 as court will start at 10:00**.
