- 2. For all matters enrolled for **Tuesday**, there shall be a physical hearing in court 9F on the ninth floor of the court building, unless advised otherwise.
- 3. Matters that are enrolled for Monday, if any, will be done on a virtual Microsoft platform.

- 4. Parties in matters that are enrolled for Wednesday, Thursday or Friday, or which stand down to those days will be informed, or must otherwise contact the secretary of the presiding judge to ascertain whether the hearing will be physical or virtual.
- 5. All matters must be accessible on the **CaseLines system** to avoid removal, and the Judge's secretary must have been invited to the Caselines file. This must take place before 16h00 on Friday, 17 February 2023.
- 6. Without derogating from paragraph 3 above, it is suggested that practitioners create bundles on Court Online so that court documents can appear on CaseLines. For assistance in that regard, please contact the Court Online call centre (010 493-2600).
- 7. Due to an unresolved technical problem, Acting Judge Gilbert may not be able not able to access and view court bundles when making use of the Court Online system, and so essential that all matters are accessible on the Caselines system.
- 8. It is the responsibility of counsel to ensure that the draft order that is uploaded electronically is in the correct format. Kindly ensure that the name of the presiding judge appears on the order (heading of the order to be changed from Draft Order to Court Order or Order).
- 9. Practice notes need to be uploaded in each matter as soon as possible, and not later than 09h00 on Monday 20 February 2022.
