4. In matter **T2** counsel will be required to address the Court on:
  - 4.1. Can this interlocutory application be determined while the question of the Court's jurisdiction remains unresolved?
  - 4.2. If the offending notice (page B15) is a notice as contemplated in Rule 28(1) and the proposed amendment has not been affected, has it not lapsed?
  - 4.3. Rule 28 provides an internal remedy for notices of intention to amend. This remedy has not been invoked by the applicant. Is the choice of remedy pursued by the applicant competent?
  - 4.4. In the event that the offending notice has not lapsed and the remedy invoked by the applicant is competent, what is the applicant's prejudice?
5. In matter **B34** counsel will be required to address the Court on:
  - 5.1. The applicant relies on various documents downloaded from a website.
    - 5.1.1.1. Are these documents admissible?
    - 5.1.1.2. If so, what weight must be attached thereto?
    - 5.1.1.3. If the documents are inadmissible, has the applicant made out a case for relief?
