- Documents must be uploaded in all matters to CaseLines or Courtonline. Only matters that have been uploaded on CaseLines or Courtonline shall be heard. All non-compliant unopposed motions shall automatically be removed from the roll.
- 2. A practice note must be uploaded to *CaseLines* or Courtonline and must include reference to when the application was served, how it was served and details of the nature of the matter.
- 3. The hearing of all unopposed motions will be conducted in open/physical court.
- 4. The customary draft order (incorporating Counsel's name, email address and cell number) must be presented among the documents uploaded to *CaseLines or Court Online*. Parties are also requested to bring hard copies of their draft orders to court.
- 5. Parties who wish to remove or withdraw their matters are requested to do so by no later than 13:00 on Friday the 24<sup>th</sup> of February 2023.
