2. For all matters enrolled for **TUESDAY** the 7th March 2023 for **ROLL CALL**, there shall be a physical hearing in **COURT 9F** on the ninth floor of the court building the calling of the roll will commence at **09:30am**, unless advised otherwise.
3. His Honourable Judge Thompson (AJ) will give direction on the day of roll call on how matters set down for Wednesday to Friday are to be heard (either open court or virtually).

6. Without derogating from paragraph 4 above, it is suggested that practitioners create bundles on Court Online so that court documents can appear on CaseLines. For assistance in that regard, please contact the Court Online call centre (010 493-2600).
7. Due to an unresolved technical problem, Honourable Judge Thompson may not be able not to access and view court bundles when making use of the Court Online system, and so essentially, all matters **MUST** be accessible on the Caselines system.
8. It is the responsibility of counsel to ensure that the draft order that is uploaded electronically is in the correct format. Kindly ensure that the name of the presiding judge appears on the order (heading of the order to be changed from Draft Order to Court Order or Order).
