These orders must be signature ready (i.e. remove the word "draft" from the tramlines, delete the "further and/or alternative relief" prayer etc.) Orders will be delivered by uploading same onto CaseLines/CourtOnline.
- 4. The attention of all parties is specifically drawn to the provisions of subparagraph 164.1 of the Judge President's Revised Practice Directive 1 of 2021 (8 July 2022) dealing with practice notes. These are to be uploaded at least one full court day prior to the date of the hearing. The purpose of the practice note is to assist the Court in the efficient disposal of the matter. In the premises, a practice note which merely describes what type of matter the Court is dealing with is of no assistance at all.
