1. **The urgent court before Malungana AJ will be held in open court. The court room allocation will be made known to parties before Tuesday, 25/04/2023.**
2. Applicants are to ensure that documents are accessible on Caselines as well as Court Online.
3. Counsel must file a practice note in the format set out in the *pro forma* practice note furnished herewith as Annexure "A" before 17:00 on 21 April 2023..
4. Practice notes must be immediately emailed to Ms Modise at KeModise@judiciary.org.za and also be uploaded to Caselines. Practitioners are requested to name the file of the document (.doc, .docx or pdf) commencing with a hashtag (#) and the number of the matter on the roll. For example: #1

Brombacher\_draft Order\_Malungana AJ.docx.

5. Should one or both parties require a virtual hearing, such request should be dealt with in their practice notes.
6. Concise heads of argument consisting of no more than 6 pages must be filed detailing the nature of the matter, justification for relief sought, the grounds of urgency (or lack thereof), the main points in contention and a reference to any Statutes, Regulations and cases that will be relied on.
7. In respect of those matters where reliance for the relief sought is placed on a Statute, Regulations or any particular case/s, copied of thereof (or where the document is long the relevant portions) and the case must be uploaded to Caselines.
8. Counsel are reminded that applicants must upload to Caselines a draft order containing the relief sought in **MS Word format**. Matters will not be entertained in the absence thereof.
9. Parties are required to immediately inform the court via email at [KeModise@judiciary.org.za](mailto:KeModise@judiciary.org.za) should any matter be settled, withdrawn or removed or, for any other reason, not be proceeding in the urgent court.
