  - 2.2. whether the legal question has been determined by the Constitutional Court, or the Supreme Court of Appeal, or a Full Court of our division, and if so to list such authorities;
  - 2.3. If neither the Constitutional Court, the Supreme Court of Appeal or a Full Court of our division have settled the legal question, whether any Full Court or High Court in any division nationally, had occasion to determine the legal question in issue, and if so to list such authorities.
3. The Addendum shall be signed by representatives of both parties and must be uploaded on CaseLines on or before Friday 21 April 2023.
