## **Directive for Special interlocutory court**

- 1. You are referred to the Directive of the Deputy Judge President dated 12 May 2023 which amends chapter 8 of the JP's Directive 1 of 2021.
- 2. Practice notes must be filed by 13 June 2023 at 17h00 and in the event of opposed matters, brief heads must be filed by Thursday 15 June by 12h00. If no practice note is filed the matter will be removed.
- 3. Should a matter become opposed on the day of the unopposed hearing, then the opposing counsel will have to deal with the matter and will have to file papers and succinct heads in order for the matter to be heard on the designated date. Punitive costs will be granted to a party who abuse the process and files a notice to oppose at the last hour in an attempt to undermine the process of allowing the appeal or trial to take its course without delays.
- 4. All draft orders are to be uploaded by 13 June 2023 at 17h00.
- 5. All Court Online matters are to be linked/bundled to Caselines, if the matter cannot be opened on CaseLines, the matter will be removed.
