- 6. In order for your matter to be timeously considered, please ensure that all relevant documentation is uploaded to caselines by 12h00 on Friday, 23 June 2023.
- 7. Counsel/Practitioners appearing before the court should be robed for the hearing.
- 8. The decorum of the court is to be maintained at all times.
- 9. Settlements and removals will be considered on a case by case basis. Should you settle prior to your hearing, please ensure that a note is made on caselines advising the Judge of the status of the matter. In appropriate circumstances, an order may be granted without the need for an appearance
- In matters where a curator ad litem has been appointed, please ensure that the curator has prepared a report and is present in court for the application, unless specifically excused.
