2. Save for matters that have been specifically set down on days other than Tuesday, there will be a roll call on 18 July 2023, at 10h00.
3. Draft orders must be duly completed and compliant (i.e. must contain the details of counsel, reflect the date of the hearing, and the Judge's particulars). Draft orders must be uploaded onto CaseLines/CourtOnline in PDF and **Word** format, and counsel must bring two physical copies to the hearing in court. These orders must be signature ready (i.e. **remove** the word "draft" from the tramlines, **delete** the "further and/or alternative relief" prayer etc.) Orders will be delivered by uploading same onto CaseLines/CourtOnline.
4. Parties must follow the "7-Steps" to ensure that their CourtOnline matters bundle onto CaseLines.
