**Directives by Wanless AJ:**

1. The Hon. Acting Judge Wanless will hear the matters hereunder in **open court** on the dates and times stated. (The relevant court number will be disclosed in due course – please see JSA website for daily court allocations).
2. There will be no roll call so parties need not present themselves on any other day save as stated below. **Parties with later slots during the day should remain available and contactable in case of an earlier start.** An appearance will be required in all matters (save for those that have been duly removed by Notice).
3. Draft orders must be duly completed and compliant (i.e. must contain the details of counsel, reflect the date of the hearing, and the Judge's particulars). Draft orders must be uploaded onto CaseLines/CourtOnline in PDF and **Word** format, and counsel must bring two physical copies to the hearing in court. These orders must be signature ready (i.e. **remove** the word "draft" from the tramlines, **delete** the "further and/or alternative relief" prayer etc.) Orders will be delivered by uploading same onto CaseLines/CourtOnline.
4. Parties with CourtOnline matters must follow the "7-Steps" to ensure that their CourtOnline matters bundle onto CaseLines.
