- 3. A practice note must be uploaded must include reference to when the application was served, how it was served and the nature of the matter.
- 4. The hearing of all unopposed motions will be conducted in open court. The courtroom allocation will be circulated by the DJP's secretary.
- The customary draft order (incorporating Counsel's name, email address and cell number) must be presented among the documents uploaded. Parties are also requested to bring hard copies of their draft orders to court.

6. Parties who wish to remove or withdraw their matters are requested to do so by no later than 16:00 on Thursday, 17 August 2023.
