CONSOLIDATED DIRECTIVES BY HONOURABLE ACTING JUDGE THUPAATLASE

DIRECTIVES

1. In terms of paragraph 18 of Chapter 9.23 of the Gauteng Local Division Johannesburg Practice Manual dated October 2018 (*'the High Court Practice Manual'*) read with paragraph 183 of the Judge President's Revised Consolidated Directive of 18 September 2020 (*'the Revised Consolidated Directive'*), the relevant papers were to have been filed by 12h00 on 28 September 2023.
2. **Documents must be uploaded in all matters to the CaseLines digital platform**, including in instances where it is a CourtOnline matter. A matter which is non-compliant with this requirement shall not be entertained. Only matters that have been uploaded on CaseLines shall be heard. **All non-compliant matters shall be removed from the roll.**
 - For assistance with bundling a CourtOnline matter to CaseLines, kindly follow the attached 7 Steps or contact the Court Online call centre 010 493 2600.

3. If your matter has not been enrolled accordingly, kindly please liaise with the urgent court Registrar, Ms. Dieketseng Matsie who sits in office 002 and her telephone numbers are as follows: 010 494 8574.
4. The hearing of all urgent applications (both opposed and unopposed) will be conducted as videoconferences using the Microsoft Teams platform. The link to the videoconferences must be obtained from this roll as it will not be e-mailed separately.
 - Counsel are required to remain on standby in the MS Teams hearing, despite the time allocation. Should a matter be finalised earlier than expected, the next matter will be called.
5. Attention is drawn to the provisions of chapter 10.5 of the High Court Practice Manual, and in particular paragraph 1 thereof which provides:
 - 5.1. 'It is hereby emphasised that no person may film or electronically record judicial proceedings without the prior permission of the presiding Judge. The granting and the terms of any such permission is within the discretion of the presiding Judge.....'

6. Attention is further drawn to the provisions of paragraph 245 of the Revised Consolidated Directive dealing with media access to virtual court hearings and which expressly provides that such Directive does not replace the provisions set out in the High Court Practice Manual unless a deviation is specified and then only for the duration of the national state of disaster.
7. **Self-represented litigants** will be accommodated in **Office 1236** on the 12th floor at the Johannesburg High Court, in circumstances where they do not have access to their own facilities to join the videoconference via MS Teams; attorneys are required to advise unrepresented litigants of same, where possible.
 - 7.1. Self-represented litigations making use of the Courts facilities are required to be at court by 09h00 on the day of their hearing.
 - 7.2. Please ensure that you inform MMagadla@judiciary.org.za, by no later than 08h30 on the day of your hearing, of your attendance at court.
8. Should an order be granted, a Microsoft Word version of the draft order must be emailed to the Judge's Secretary (MMagadla@judiciary.org.za) as soon as possible after the matter has been heard.
9. Stamped and signed copies of draft orders will be uploaded to CaseLines/CourtOnline within a day of the order being granted.
10. **The MS Teams links have been attached below. Parties are required to use the link as per their allocation date.**
 - **ie the MS Teams link under Tuesday, 3 October 2023 should be used by everyone, to join that respective hearing for a roll call to be conducted.**
