1. Documents in Courtonline matters must be uploaded to Courtonline and bundled onto Caselines. Only matters that have been uploaded and bundled onto CaseLines shall be heard. All non-compliant opposed motions shall automatically be removed from the roll.
2. Practitioners should ensure that bundles are created on Court Online so that their court documents are accessible on CaseLines. For assistance in this regard, please contact the Court Online call centre (010 493-2600).
3. Parties should ensure that their practice note and heads of argument have been uploaded onto the case file.
4. In the opposed motions in which the party appears in person, such an unrepresented party shall go to the Court building and approach the designated official at the Court building who shall render assistance to that litigant through the use of the virtual Courtroom. A notice to this effect shall be posted in the foyer of the Court by the Judge's Secretary.
5. The hearing of all opposed motions will be conducted as a videoconference on *Microsoft Teams*. All appearing Legal Practitioners are required to join the meeting on the day of the hearing at **09:45 as court will start at 10:00**.
