**DIRECTIVES**

  - All draft orders must have the Judge's name and the correct date on it. (Before Manamela AJ on 12 October 2023);
  - The word "draft" may be omitted from the order;
  - Counsel are to hand up 1 copy of the draft in court;
  - Signed orders will be uploaded within 7 court days.
