JUDGE'S DIRECTIVE:

- 1. All matters are to proceed in open/physical court at 10H00.
- 2. Introductions will take place at 10:45 in chambers 1001.
- 3. An appearance will be required in all matters (save for those that have been duly removed by Notice).
- 4. Draft orders must be duly completed and compliant (i.e. must contain the details of counsel, reflect the date of the hearing, and the Judge's particulars). Draft orders must be uploaded onto CaseLines/CourtOnline and counsel must bring a copy to the hearing in court. This order must be signature ready (i.e. remove the word "draft" from the tramlines, delete the "further and/or alternative relief" prayer etc.) Orders will be delivered by uploading same onto CaseLines/CourtOnline.
- 5. The attention of all parties is specifically drawn to the provisions of subparagraph 164.1 of the Judge President's Revised Practice Directive 2 of 2022 (8 July 2022) dealing with practice notes. These are to be uploaded at least one full court day prior to the date of the hearing. The purpose of the practice note is to assist the Court in the efficient disposal of the matter. In the premises, a practice note which merely describes what type of matter the Court is dealing with is of no assistance at all. The practice note should set out all the pertinent issues of the matter and precisely where each may be found on CaseLines/CourtOnline. In this way, the Court will be able to ascertain whether the applicant is entitled to the relief sought or not.
- 6. Parties with CourtOnline matters must follow the "7-Steps" to ensure that their CourtOnline matters bundle onto CaseLines.
- 7. <u>Matters that are HIGHLIGHTED DO NOT APPEAR ON CASELINES. THE HONOURABLE JUDGE HAS THEREFORE NOT HAD SIGHT OF YOUR PAPERS.</u> Legal representatives are to ensure that this is remedied without delay.
- 8. NB!! Every file on CaseLines must comply with paragraph 7 of Part B of directive 1 of 2021 and should also include a CASELINES INDEX. Any file that does not comply runs the risk of not being dealt with.

- 9. All documents must be uploaded correctly in separate sections.
- 10. Parties should please note that Judge's secretaries **DO NOT** assist in creating the bundle or uploading documents onto Caselines and CourtOnline.
