### **UNOPPOSED DIRECTIVE:**

1. The matters below will be called in open court in the order that they appear on the roll, at **10h00** on **Tuesday, 17<sup>th</sup> of October 2023**. If counsel is not present and has not been excused when the matter is called, the matter will be moved to the end of the roll and called again. If counsel is not present when the matter is called for a second time, the matter will be removed from the roll.
2. All material documents to be placed before the court, including practice notes and draft orders, must be uploaded to **Caselines** by no later than noon on **Friday, 13<sup>th</sup> of October 2023**, failing which the matter may be removed from the roll.
3. It is emphasised that the parties are required to make their documents available on the **Caselines** system. Where matters have commenced on the Court Online system, the parties or their legal representatives must ensure that the Court Online entry is set so as to ensure that the whole file is available on **Caselines**. Matters not accessible on **Caselines** will be removed from the roll.
4. Parties should note that Judge's secretary cannot assist parties in creating the bundle and uploading documents on court online to caselines and should liaise with the court online helpdesk at **CourtOnlineSupport@judiciary.org.za**; telephone **Number: -010 493 2600** or go to **office 008**.
5. The draft order must clearly reflect the surname of the judge (**M VAN NIEUWENHUIZEN**), date, the name of counsel, the attorney(s) and their respective email addresses. The draft order should be in a format ready to be made an order of court (i.e. the word "draft" should be deleted and if the phrase "further and/or alternative relief" appears in your draft order it must be deleted).
6. Piece-meal filing of affidavits and other documents will NOT be allowed.
7. Counsel are excused from introducing themselves in chambers.
