AMENDED OPPOSED DIRECTIVE:

- All parties who have not yet convened a pre-hearing conference in accordance with paragraph 104 of the Judge-President's Consolidated Practice Directive dated 18 September 2020, are requested to do so without delay and joint practice notes must be uploaded onto CaseLines forthwith by no later than THURSDAY, 12 OCTOBER 2023.
- Counsel are to deliver hard copies with their practice notes; all the papers and heads of argument to the
 office of the Hon. Acting Judge Van Nieuwenhuizen at Office 1003, 10th Floor, Johannesburg High Court by
 no later than 14h00 on Thursday 12 October 2023.
- 3. If a matter becomes settled or the parties agree to postpone, the Judge's Registrar is to be informed without delay.
- 4. Counsel are to furnish the Court with hard copies of draft court orders and to ensure same is uploaded in both word and Pdf format on the court online and caseline portal timeously.
- 5. The Judge may communicate with the parties' legal representatives via electronic file. Legal representatives are to look out for these communications and are requested to respond to each communication.
- 6. Counsel may be excused from introducing themselves in chambers. Introductions may be made in Court.
- 7. **Mode of hearing:** The default mode is a physical hearing.
 - 7.1. If one or more counsel who are to address the court are not domiciled in Gauteng, a request may be made for hearing by video link.
 - 7.2. Such request must be made to all interested persons as soon as possible before the allocated hearing date.

- 7.3. Even if the mode of hearing is agreed between the parties, the Judge retains a discretion as to what mode is appropriate, having regard to the reasonable needs of all parties' representatives and the Court.
