DIRECTIVES BY THE HON. ACTING JUDGEN. HORN:

- 1. Matters will be heard in open court.**
- 2. An appearance will be required in all matters (save for those that have been duly removed by Notice). All notices of removal are to be uploaded and emailed to Ms Estelle Manuel at the email address provided above.**
- 3. Where a matter has become settled, Ms Manuel should be notified by email forthwith.**
- 4. Where counsel have matters in any of the other RAF default judgment courts on the same day, Ms Manuel should be advised accordingly to avoid their matters being struck for non-appearance.**

Orders will be delivered by uploading same onto CaseLines/CourtOnline.**
- 6. Parties with CourtOnline matters must follow the "7-Steps" to ensure that their CourtOnline matters bundle onto CaseLines.**
- 7.
