CIVIL TRIAL DEFAULT JUDGMENT

DIRECTIVES BY THE HON. ACTING JUDGE- N. HORN:

- 1. Matters will be heard in open court.**
- 2. An appearance will be required in all matters (save for those that have been duly removed by Notice). All notices of removal are to be uploaded and emailed to Ms Estelle Manuel at the email address provided above.**
- 3. Where a matter has become settled, Ms Manuel should be notified by email forthwith.**
- 4. Where counsel have matters in any of the other RAF default judgment courts on the same day, Ms Manuel should be advised accordingly to avoid their matters being struck for non-appearance.**
- 5. Draft orders must be duly completed and compliant (i.e. must contain the details of counsel, reflect the date of the hearing, and the Judge's particulars). Draft orders must be uploaded onto CaseLines/CourtOnline in PDF and Word format, and counsel must bring a copy to court. This order must be signature ready (i.e. remove the word "draft" from the tramlines, delete the "further and/or alternative relief" prayer). Orders will be delivered by uploading same onto CaseLines/CourtOnline.**
- 6. Parties with CourtOnline matters must follow the "7-Steps" to ensure that their CourtOnline matters bundle onto CaseLines.**
- 7. Parties should note that Judge's secretary cannot assist parties in creating the bundle and uploading documents on court online to caselines and should liaise with the court online helpdesk at CourtOnlineSupport@judiciary.org.za; telephone Number: -010 493 2600 or go to office 008. Any other challenges in obtaining the order are to be directed to the Court online for assistance.**
