The following processes and procedures shall apply to URGENT FAMILY COURT APPLICATIONS before Dosio J:

- 1. All matters are to proceed in open/physical court for the entire week.
- 2. Court will commence at 10h00 unless otherwise indicated.
- 3. Allocations for the week will be determined at roll call on 31 October 2023.
- 4. Settlements, postponements and removals will be called first.
- 5. The customary draft order (incorporating Counsel's name, email address and cell number) must be presented among the documents uploaded to *CaseLines*.

- 6. Matters where parties cannot reach agreement on a Joint Practice Note, must file their respective Practice Notes by no later than Friday 27 October at 13h00. In the absence of a Joint Practice Note, failure to upload Practice Notes by both parties, in an opposed matter will result in the matter being removed.
- 7. All Practice Notes and Heads of argument must be e-mailed to the Judges Secretary in Word format by no later than Friday 27 October at 13h00.
- 8. Matters initiated on Court Online must be bundled to *Caselines* in accordance with the Practice Directives and "7 steps to bundle" annexed hereto. The urgent court bundles will be frozen as per 27 October 2023 at 13h00 and all additional documents must be forwarded to the following e-mail addresses: ureddy@judiciary.org.za / ushallowergamail.com
- 9. Matters initiated on Court Online that have not been bundled to Caselines will not be heard and will be removed/struck from the roll.
- 10. Only matters that have been bundled and are accessible on *Caselines* shall be heard.
