# The following processes and procedures shall apply to ALL URGENT APPLICATIONS before Dosio J:

- 1. All matters are to proceed in open/physical court for the entire week.
- 2. Court will commence at 10h00 unless otherwise indicated.
- 3. The hearing of all urgent applications after normal court hours will be conducted as a videoconference on **MS Teams**. (one link will be used for the week and incorporated into the roll)

- 4. The customary draft order and practice note (incorporating Counsel's name, email address and cell number) must be presented among the documents uploaded to *CaseLines*.
- 5. Documents must be uploaded in all matters to *CaseLines*. Only matters that have been uploaded on *CaseLines* shall be heard. Matters initiated on Court Online must be bundled to *Caselines* in accordance with the Practice Directives and "7 steps to bundle". All non-compliant urgent applications shall automatically be removed from the roll. If matters are not bundled to *Caselines* by 21H00 on 16 November 2023, the matters will be removed.
- 6. In respect to matters set down for Tuesday, 21 November 2023, a Practice Note must be uploaded to *Caselines* together with a Draft Order by 19H00 on 16 November 2023. In the event that the matter is opposed, answering and replying affidavits <u>must</u> be emailed to UReddy@judiciary.org.za. In respect to matters set down on other days, the same applies.
- 7. Bundles on *CaseLines* will be frozen as at 19H00 on 16 November 2023, any further communication relating to matters on the roll must be emailed to <u>UReddy@judiciary.org.za</u>
- 8. Where a duplication of matters exists, parties must bring same to the attention of Mr Reddy by no later than Thursday, 16 November 2023 at 21H00 and direct him to the correct matter, failure to do so will result in the matter being removed/struck off the roll.
