Practitioners' are advised to properly create on online bundle in preparation for the hearing of the matter and to as well avoid the removal of the matter from the roll and last minute (prohibited) duplication of matter(s) between the court online and case lines systems.
- 6. Matters will be called in numerical order as per the attached court roll.
- 7. If counsel is not present and has not been excused, the matter will be moved to the end of the roll and called again. If counsel is not present when the matter is called at the end of the roll, the matter will be removed from the roll.
- 8. All material documents to be placed before the court, including practice notes and draft orders must be uploaded on Caselines by no later than 12h00 on 24 November 2023, failing which the matter may be removed from the roll. Documents uploaded outside the stipulated times will not be considered and will result in the matter being removed from the roll.
- 9. The order should set out the date of the hearing, number on roll, Judge's name (i.e Hartford AJ) and the name of Counsel/Practitioner and those of the instructing attorney should appear at the end of the draft order.
