DIRECTIVES BY HONOURABLE ACTING JUDGE BUIRSKI

1. All matters on the roll before Buirski AJ will be heard virtually (MS teams).

3. The papers should be in order when the matter is heard and no matter will stand down until later in the week.
4. By not later than 13h00 on Friday 2 February 2024 all Plaintiff's counsel must have uploaded on to case lines practice notes that set out succinctly (in not more than 3 pages):
 - 4.1. Number on the roll;
 - 4.2. Name of legal representatives and mobile number;
 - 4.3. Whether matter is ripe to be heard?
 - 4.4. Details providing proof of service on the RAF
 - 4.4.1. of summons;
 - 4.4.2. of the notice of set down.
 - 4.5. Details of why matter is being heard by default?

- 4.6. Whether the matter is ripe to be heard?
 - 4.7. What material evidence is in affidavit form, and what material evidence must be orally adduced?
 - 4.8. A succinct explanation as to why the quantum on each head of damage is justifiable.
 - 4.9. Where necessary, all documents in the court file must be cross referenced to the practice note.
 - 4.10. The attached draft order.

5. Please note that there shall be no late practice notes received. Please note further that:
 - 5.1. any failure to comply with this directive will result in the matter being automatically removed from the roll; and
 - 5.2. A practice note that does not comply with the prescribed contents shall also result in the matter being struck off the roll with no costs allowed.
