**CIVIL TRIAL DEFAULT JUDGMENT**

**DIRECTIVE:**

1. All matters will be called in open Court. If counsel is not present and has not been excused when the matter is called, the matter will be moved to the end of the roll and called again. If counsel is not present when the matter is called for a second time, the matter will be removed from the roll.
2. All material documents to be placed before the court, including practice notes and draft orders, must be uploaded to Caselines by no later than noon on the day preceding the day of hearing, failing which the matter may be removed from the roll.
3. Applicant's practice note should include inter alia the following:
  - 3.1 Where general damages is claimed, a list of authorities with a brief description of injuries, figures awarded and the quantum of such award in 2023/2024, monetary terms.
  - 3.2 Where loss of income and/or income earning capacity is claimed, an address (no more than a page) on pre- and post-morbid scenarios as well as contentions in relation to both pre- and post-morbid contingency deductions.
4. Where past medical, hospital and/or related costs are claimed, appropriate evidence relating to the reasonableness of such costs should be uploaded to Caselines.
5. Parties who are experiencing any difficulties with making their matter(s) available on the Caseline system are invited to engage timeously with the Presiding Judge's registrar.
6. When moving their matters, counsel will be expected to hand up a draft order in hardcopy.
7. The draft order must clearly reflect the surname of the judge ( Saint AJ ), date, the name of counsel, the attorney(s) and their respective email addresses and telephone numbers. The draft order should be in a format ready to be made an order of court (i.e. the word "draft" should be deleted and if the phrase 'further and/or alternative relief' appears in your draft order it must be deleted.
8. Piece-meal filing of affidavits and other documents will NOT be allowed.
9. Where merits have not been settled or conceded, a recent affidavit in support of the Plaintiff's claim on merits will need to be uploaded, and the signatory to such affidavit be available to testify if necessary.
9. If there is a contingency fee agreement in place, the agreement itself must be uploaded to Caselines.
10. If settlement is reached between the parties the necessary affidavits of attorney and plaintiff will need to be handed up.
10. Counsel are excused from introducing themselves in chambers. Introductions shall take place at the hearing.
