- 1. The matters set out below will be heard in open court on the dates and at the times indicated.
- Any outstanding written submissions or joint practice notes in accordance with paragraph 120 of the Judge President's Consolidated Practice Directive, dated 11 June 2021, must be uploaded to Caselines and emailed to Mr. Chauke by no later than noon on Wednesday 7 February 2024.
- 3. The applicant's attorney must produce a core bundle of documents to be placed before the presiding Judge in hardcopy. That bundle must consist of the documents set out below, in the order that they are listed, and bearing their Caselines pagination
 - a. The joint practice note;
 - b. the applicant's practice note, heads of argument, chronology and list of authorities:
 - c. the respondent's practice note, heads of argument, chronology (if any) and list of authorities;
 - d. all the affidavits and annexures filed in the application to be decided, in chronological order; and
 - e. any other document that is, in the opinion of either party, material to the application.

- 4. The applicant's attorney in each matter must deliver a hardcopy of the core bundle, bound in a lever arch or similar file, to Mr. Chauke at Room 1101 of the High Court building, by no later than noon on Wednesday 7 February 2024.
- 5. In the event that a matter becomes settled or the parties agree on a postponement or removal from the roll, Mr. Chauke must be contacted immediately with an agreed draft order for the settlement or further conduct of the matter.
