3. Court proceedings will start at 10:00am
4. Senior counsel will be given preference, whereafter matters will be called as they appear on the roll.
5. The usual protocols regarding the recording of the proceedings, the requirement to mute the microphone and video will apply.
6. Counsel are requested to ensure that the device used for the hearing is functional prior to the hearing to limit disruptions and to assist ensure efficient use of the time allocated.
7. Where no notice of set down has been given to the defendant at least five days before the hearing date, the matter should be removed from the roll and timeous notice given.

8. In any matter where the service of summons was effected more than six months before the hearing date, personal service by sheriff of the notice of set down is required unless it can be demonstrated that the defendant is aware that the matter is proceeding on the hearing date.

9. Matters that have not been uploaded to Caselines by 16h00 on Monday, 19 February 2024 will not be heard and are to be removed from the roll.

10. Any matter where the required practice notes and affidavit/s in terms of Section O of the Consolidated Practice Directive of 1 of 2023 have not been uploaded to the Caselines file by 16h00 on Monday, 19 February 2024 are to be removed from the roll.
