**Directives by Wanless J:**

1. The Hon. Judge Wanless will hear the matters hereunder in **open court** at **10h00**. (The relevant court number will be disclosed in due course – please check the JSA website for daily court allocations).
2. An appearance will be required in all matters (save for those that have been duly removed by Notice).
3. Draft orders must be duly completed and compliant (i.e. must contain the details of counsel, reflect the date of the hearing and the Judge's particulars). Draft orders must be uploaded onto Caselines in PDF and **Word** format and Counsel must bring a physical copy to the hearing in court. These orders must be signature ready (i.e. **remove** the word "draft" from the tramlines, **delete** the "*further and/or alternative relief*" prayer etc.) Orders will be delivered by uploading same onto Caselines/CourtOnline.

4. The attention of all legal practitioners is drawn to the provisions of the JUDGE PRESIDENT’S CONSOLIDATED DIRECTIVE (19 February 2024) in respect of practice notes (30.5 and 30.6 refer). These should already have been filed with the Notice of Set Down. Practice notes which FULLY comply with those provisions are to be uploaded onto Caselines by no later than the close of business on Wednesday, 28 February 2024 and must contain all of the references as set out in the Practice Directive in order to assist the Court in reading the papers. If not the matter will not be heard.
5. Please **bring hard copies** of the relevant **settlement agreements**.
6. Parties with CourtOnline matters must follow the “7-Steps” to ensure that their CourtOnline matters bundle onto Caselines.
