DIRECTIVES BY HONOURABLE ACTING JUDGE ROLLER

2. Roll call of all the Default Judgment matters on the week's roll will start promptly at 10h00, during which Counsel/attorneys should give an update on the status of their matters. Allocation of matters that are proceeding by default will be done by Honourable Roller AJ at Roll Court.
3. Please inform the secretary, Mr Mzoxolo Magadla at MMagadla@judiciary.org.za as soon as possible, and preferably on Monday, 11 March 2024, of any removals, settlements or withdrawals.
4. In matters that will proceed by Default, Counsel must upload Heads of argument and caselaw (On the issue of General damages three cases will be sufficient) onto Case lines by latest 10 am on the court day preceding the date in the week allocated by Honourable Judge Roller AJ for the hearing of the matter.
5. Introductions to be done in open court when your matter is called.

6. One hard copy of your draft order should be available to be handed up in court.
7. In matters where there is no bundle created on Caselines, there are no documents before the Judge, therefore the matters will be removed from the roll for non-compliance with the directives.
