## **Directives by Wanless J:**

- 1. The Hon. Judge Wanless will hear the matters hereunder in **open court** at **10h00**. (The relevant court number will be disclosed in due course please check the JSA website for daily court allocations).
- 2. An appearance will be required in all matters (save for those that have been duly removed by Notice).
- 3. Draft orders must be duly completed and compliant (i.e. must contain the details of Counsel, reflect the date of the hearing, and the Judge's particulars). Draft orders must be uploaded onto Caselines/CourtOnline in PDF and Word format and Counsel must bring a physical copy to the hearing in court. This order must be signature ready (i.e. remove the word "draft" from the tramlines, delete the "further and/or alternative relief" prayer etc.) Orders will be delivered by uploading same onto Caselines/CourtOnline.

- 4. The attention of all legal practitioners is drawn to the provisions of the AMENDED CONSOLIDATED PRACTICE DIRECTIVE 1 OF 2024 (24 January 2024) in respect of unopposed motions. In particular the attention of legal practioners is drawn to, *inter alia*, subsections 26.5.2; 26.7; 26.8; 26.10 and 26.11. The purpose of the Practice Note is to assist the Court in the efficient disposal of the matter. A Practice Note which does not comply therewith will result in the matter not being heard. Similarly, where no Practice Note and/or Draft Order has not been uploaded onto Caselines/CourtOnline the matter will not be heard.
- 5. Parties with CourtOnline matters must follow the "7-Steps" to ensure that their CourtOnline matters bundle onto CaseLines.
- 6.
